## **ENVIRONMENTAL AWARENESS FOR CIVIL CONSTRUCTION PROJECTS**

*Are you working on a civil construction project where your activities are likely to impact on the environment? For DPTI contracts, it is a requirement for at least 2 people on site to be trained in this course.*

### **COURSE OVERVIEW**

This course provides construction workers with the knowledge to identify environmental issues associated with their activities and best practice methods to minimise environmental impact and outline environmental legal obligations relevant to construction activities.

Civil Train SA engages the specialist services of AECOM to deliver this training.

This is an approved DPTI course and is based on the DPTI workbook 'Environmental Awareness for Civil Construction Projects.' It is a requirement for DPTI contracts for at least 2 people on site to have undertaken this training.

### **COURSE OUTCOMES**

On completion of the course you will be able to:

- Understand common environmental terms
- State legal obligations and responsibilities in relation to environmental management
- Recognise common environmental impacts on construction sites and potential impacts resulting from work activities
- Identify accepted current environmental management best practices for relevant workplace activities
- Identify situations which require further advice about appropriate work practices to minimise environmental damage.

Upon completion you will receive a Statement of Attendance.

### **COURSE DURATION**

This course is one day (8 hours).

### **DELIVERY AND ASSESSMENT**

This course is delivered and assessed face to face.

There are theory and practical training and assessment components to the course.
